- Low to medium tack

4760 Medium/HighTack

- Tape for UV and solvent-based screen print inks and clear coats

Prespacing Tapes

- Used to mark die cut graphics
- Holds cut vinyl lettering and emblems together during installation

4885 High Tack

- For difficult to transfer graphics, thermal die-cut and textured window graphics

4761RLA High Tack

- Use with air egress vinyls, die cut and plotter cut graphics
- Conform® Release Liner Adhesion prevents tunneling and edge curl

4761RLA High Tack

- Small and medium die cut graphics
- Compatible with most vinyl films and graphics with overlaminates
- Conform® Release Liner Adhesion prevents tunneling and edge curl
